### 2020 Legislative Session Florida Health IT Day in Tallahassee

On November 13, 2019, several members of South Florida HIMSS ventured to Tallahassee for a day of learning, sharing and advocating. Unfortunately, some of our delegation was not able to make it due to travel issues, but those who did had a very interesting time. This year, we made the conscious decision to hold our Health IT Day during one of the interim committee weeks, as opposed to holding Health IT Day during session. The advocacy committee believed that we would have greater access to legislators, since they would not be called into session in either Chamber.

We started the day observing the House Health Quality Sub-committee hearing on House Bill 389 -- Testing for and Treatment of Influenza and Streptococcus, and House Bill 409 -- Health Care Licensing Requirements. The delegation that participated in these hearings came away with a better understanding of the political process.

From there, we were briefed by Sierra Anderson, from U.S. Senator Rick Scott's office. Ms. Anderson spoke about the legislative priorities Senator Scott's office has embarked upon this year and we shared with Ms. Anderson some of the issues that are important to HIMSS.

Ramon Maury from the Public Affairs firm of Maury Rawlins & Brown then provided an overview of how a Bill becomes a law. This was particularly timely, since several of us sat in the House Health Quality Sub-committee on and heard testimony from individuals either sponsoring, supporting or opposing the proposed legislation.

After the briefing by Ms. Anderson and the education from Mr. Maury, we had lunch and a briefing from Senator Gayle Harrell. Senator Harrell also presented SFLHIMSS with a Proclamation naming Wednesday, November 13<sup>th</sup>, 2019, Health IT Day in the Senate.

Regarding her efforts to bring interoperability to all the sister Health & Human Service agencies in the State of Florida, Senator Harrell's bill, Senate Bill 800, is a comprehensive interoperability bill that will connect, as an example, Medicaid (through ACHA), with the Department of Children and Families, the Department of Education, and the Department of Juvenile Justice, to more effectively provide a picture of the challenges and services being provided by various state agencies to troubled youth.

With any Senate bill, there needs to be an accompanying House bill, and following lunch, the group went to Representative Toledo's office to urge her legislative aid for Representative Toledo to file the accompanying bill in the House. We indicated that interoperability was one of the issues HIMSS is advocating for at a national level and this SB800 was an important issue for all Floridians. After speaking with Representative Toledo's office, SFLHIMSS members then went to some other legislative offices representing their homes and/or places of business.

Overall, those who participated in the event felt it was very worthwhile, and on a very positive note, Representative Toledo did file the corresponding House bill and Senator Harrell's bill is moving through the committee process in both the House and the Senate. We hope that next year, more SFLHIMSS members will be able to join us in Tallahassee, and watch for an announcement of next year's date in the coming months.
